Having started her career at Roketsan Savunma San. ve Tic. A.Ş., Bilge Müftüoğlu has gained experience on contracts and international transactions with regards to defence sector during her six years of tenure at Roketsan. She then, started to work at Yazıcı Law Office, which is restructured as an attorney partnership later and spent final four years of her twenty-five years of working life therein, as the managing partner. Throughout her professional career, Bilge Müftüoğlu has specialised in construction law by mainly focusing on construction and EPC (engineering procurement construction) contracts including FIDIC suite of contracts for infrastructure projects in relation to investments regarding industrial plants (natural gas and crude oil transit pipeline projects, construction of industrial plants, mine site development projects, combined cycle, hydroelectric and wind power plants, energy transmission and storage facilities); as well as construction contracts for superstructure projects (such as hotels and hospitals).
