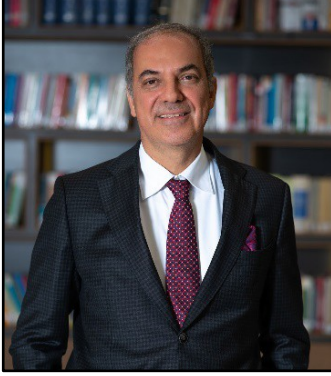

Professor Ziya Akinci is a member of the Istanbul Bar and is a permanent professor of Private International Law at Galatasaray University and the Chairman of the Department of Private International Law. He regularly teaches international law and FIDIC Contracts at Bosphorus University. Professor Akinci has broad and extensive experience in international arbitration, recognised as a “*leading individual*” by Legal500 in construction matters and international business law and ranked as number one in Chambers&Partners in the sector of Dispute Resolution. Professor Akinci is both an accomplished counsel and arbitrator.

Professor Akinci has rendered legal services in construction projects and construction contracts such as highway construction disputes, energy distribution disputes, and water and waste management plant disputes. He has a wide range of experience in resolving construction disputes; providing consulting; preparing construction contracts; and providing advice on non-contentious matters in construction projects.

Prof. Akinci recognises the importance of the DAB procedure to efficiently resolve disputes, and is very experienced in DAB proceedings as both counsel and adjudicator for construction projects in Türkiye and abroad. As counsel, Prof. Akinci focuses on preserving clients’ rights and interests to avoid protracted disputes, and safeguarding claims for the DAB proceedings. As adjudicator, Prof. Akinci identifies the fair and efficient resolution of disputes drawing from his wealth of experience.

The vast majority of Prof. Akinci’s experience listed below regarding construction disputes are variations of FIDIC Contracts and have provided a broad expertise to approach construction matters with acumen. Notably, Prof. Akinci has prolifically published articles and books on International and Public Construction Law, with a specific focus on FIDIC Contracts and Construction Law.

Professor Akıncı is the most frequently appointed arbitrator in Türkiye and is appointed in arbitral tribunals around the world, with appointments in many international arbitration proceedings under the rules of different institutions such as ICC, LCIA, ICSID, DIAC, SIAC, SCAI, SCC, ITO, TOBB, and TRAC. In addition, Professor Akıncı has extensive experience in a range of different seats and governing law, including Turkish, French, Swiss, German, Iranian, Uzbek, Kazakh, and England & Wales. Professor Akıncı also has eminent experience in several roles as chairman, sole arbitrator and co-arbitrator.

Professor Akıncı has served as a member of the ICC International Court of Arbitration for 9 years. He is a member of the ICSID Panel of Arbitrators. As the founder and President of the Istanbul Arbitration Centre (ISTAC), Professor Akıncı continues to pioneer the development and use of international and local arbitration within Turkey.
